- Clients include corporate facilities management companies, property and asset management firms, and organisations from both the public and private sectors.
- 50% of their revenue comes from their top 6 multi-site facilities/property management companies, 30% from direct-to-client contracts, 15% public sector and 5% from partnerships (as sub-contractors).
- In 2013 the company spent time defining and improving their businesses processes. As a result, the main day-to-day running of the business transferred from the directors to the long-serving Office Manager.
- Staff are continually trained and assessed. They work flexible hours and share the company ethos: to provide transparent, consistent quality services and continually exceed client's expectations.
- The company use innovative, in-house scheduling and reporting software to maximise task management efficiency.
- Their active quality management system includes ISO 9001 and ISO 14001 accreditation.
- They are Safe Contractor Approved and boast efficient Safety Management Systems.
- They are also Contractor Plus Approved (for health and safety standards).

Services

- There are 13 window cleaners, the Office Manager who runs the business day to day, and a part time Telesales Assistant.

- A 2000 sq.ft. ground-floor office, storage and maintenance space with secure car parking.
- Based in the Midlands, the rent is £8,000 p.a. and there is room to expand within the same premises.
